Remarks (if any):

The Company has adopted an RSU Scheme, which took effect as of March 1, 2014, to issue 30,200,000 ordinary shares of the Company in aggregate to identified individuals. To satisfy the grant of shares under the scheme, 14,107,500 ordinary shares of the Company were issued in aggregate on October 23, 2015, 10,200,000 ordinary shares of the Company were issued in aggregate on December 18, 2018 and 14,000,000 ordinary shares of the Company were issued in aggregate on September 3, 2019. The details of the scheme are available in the Company's 2018 annual report and 2019 interim report published on April 26, 2019 and September 26, 2019, respectively.

At the annual general meeting held on June 6, 2019, the shareholders resolved to grant a general mandate to repurchase up to 145,593,673 ordinary shares in the open market from time to time. During the period from September 5, 2019 to September 11, 2019, the Company repurchased a total of 11,158,000 ordinary shares, which have been cancelled on September 30, 2019.
